FRESH AIR is a biodegradable granular product used to eliminate odors in dumpsters and trash cans. It also will deter bugs and insects. **FRESH AIR** can be used in compactor rooms, sewage plants, landfills, garbage trucks, campsites, playgrounds, around livestock and more. **FRESH AIR** eliminates odors such as fish, trash, hospital waste, feces, and decaying waste. **FRESH AIR** uses naturally derived fragrances with corn cob as the base.

DIRECTIONS

DUMPSTERS & TRASH CANS: When trash container is empty, spread 2-4 cups of Fresh Air Granules on the bottom of each 25 square foot (5' x 5') dumpster or trash container surface area. Reapply with ever 8-10 inches of trash added to container. Repeat application after each trash pick-up service and keep trash lid closed for best effect. Can be used on ground around trash cans and dumpster as well. **CAMP SITES, RVs & GARDENS:** For use in areas around tents, picnic tables, game areas, latrines, camp sites and recreational vehicles. Liberally sprinkle on ground in 10-foot square sections. Repeat every two days as needed. **PLAYGROUNDS, GROUNDS & PUBLIC AREAS:** For playgrounds, sprinkle 1 cup of Fresh Air over every 100 square feet (10ft X 10ft) area. For parks, fairs, or other large outdoor areas, use granular spreader to distribute at the same rate in grids of 60' wide spreader applications. **LIVESTOCK STALLS & KENNELS:** Clean stall and replace with clean bedding material such as wood shavings, hay, saw dust etc. In a 10' x 10' stall, sprinkle two 8-ounce cups of Fresh Air on the bedding material. Repeat every 2 days, or as required with one 8-ounce cup. Dispose with used bedding material.
